

ROLLOVERS TO PURCHASE RETIREMENT SERVICE CREDIT

Effective January 1, 2003, pre-tax money from an eligible retirement plan or IRA may be accepted via rollover or in-service plan-to-plan transfer to purchase creditable service in the Teachers' and State Employees' Retirement System, Local Governmental Employees' Retirement System, Consolidated Judicial Retirement System, and Legislative Retirement System.
